

## Cookie Notice

This Cookie Notice explains how Luna Protocol Limited ("**Luna**", "**we**", "**us**") and "**ours**") use cookies and similar technologies to recognise you when you visit our website at <https://www.luna-protocol.com/> ("**Website**"). It explains what these technologies are and why we use them, as well as your rights to control our use of them.

### What are cookies?

Cookies are small data files that are placed on your computer or mobile device when you visit a website. Website owners can use cookies for a variety of reasons that can include enabling their websites to work (or work more efficiently), providing personalised content and advertising, and creating website analytics.

Cookies set by the website owner (in this case, Luna) are called "first party cookies". Only the website owner can access the first party cookies it sets. Cookies set by parties other than the website owner are called "third party cookies". Third party cookies enable third party features or functionality to be provided on or through the website. The parties that set these third party cookies can recognise your device both when it visits the website in question and also when it visits other websites that have partnered with them.

### Why do we use cookies?

We use first party and third party cookies for technical reasons that are strictly necessary for our Website to operate, and we refer to these as "essential" cookies. Other cookies also enable us to understand how the Website is used. This is described in more detail below.

The specific types of first and third party cookies served through our Website and the purposes they perform are described in the table below.
